

RESOLUTION 03-2018

WASTE HAULING RESOLUTION TO PROCEED

Mr. Shupe moved the adoption of the following resolution:

BE IT RESOLVED by the Board of Trustees of Richfield Township that:

SECTION 1: This Board finds and determines that:

- (a) The amount of taxes that may be raised within the ten-mill limitation will be insufficient to provide an adequate amount for the necessary requirements of Richfield Township.
- (b) It is necessary to levy a tax in excess of the ten-mill limitation for the purpose of providing for the collection and disposal of garbage or refuse, including yard waste or for the payment of costs incurred as a result of contracts made with a waste hauling company in order to provide for the collection or disposal of garbage or refuse.
- (c) This Board proposes a 1.1 mill additional levy at the rate at which it is authorized to be levied.

SECTION 2: The question of the necessary levy for the purpose of providing for the collection or disposal of garbage or refuse will be submitted to the electors of the unincorporated areas of Richfield Township at the general election to be held on May 8, 2018.

SECTION 3: The ballot form for such election must be as follows:

OFFICIAL QUESTION AND ISSUES BALLOT
PROPOSED TAX LEVY
RICHFIELD TOWNSHIP

A MAJORITY AFFIRMATIVE VOTE IS NECESSARY FOR PASSAGE

A 1.1 mill additional levy to constitute a tax for the benefit of Richfield Township for the purpose of providing for the collection and disposal of garbage or refuse, including yard waste, at a rate not exceeding 1.1 mills for each one dollar of valuation, which amounts to 11 cents for each one hundred dollars in valuation, for five (5) years, commencing in 2018, first due in calendar year 2019.

FOR THE TAX LEVY

AGAINST THE TAX LEVY

SECTION 5: This Board authorizes and directs the Fiscal Officer to certify a copy of this Resolution to the Board of Elections of Summit County immediately after passage for the submission of the ballot question to the electors of Richfield Township in accordance with Section 5705.19(V), Revised Code and to notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law for the May 8, 2018, Primary Election.



